### Submit Approval Application 45 Days Prior to Show Date

All show approval applications, appropriate fees, and FINAL show flyer (including liability disclaimer – see sample on next page) must be submitted to OFEA a minimum of 45 days prior to the desired date of the show.

Preliminary show approval may be obtained by telephone – to be confirmed with a written application form with the appropriate fee(s). The completed show approval application, a copy of the show flyer, and the appropriate show approval fee(s) should be sent to the address indicated.

### Approved Judges

All final OFEA show approvals are pending selection of an OFEA approved judge or an approved guest carded judge. Judges with guest cards may judge only one OFEA approved show during the same calendar year.

### Show Results Due Within 10 Days

Show results must be submitted to OFEA, PO Box 5754, Salem, OR 97304 within 10 days of completion of the show. If show results are not received within that time, OFEA may assess a late fee of \$5 each day until the show results are received. Results must include (for each class): class name, number of paid entries in each class, exhibitor name, horse name, judge's placings. (A copy of the class sheet is preferable).

In applying for OFEA show approval, the undersigned and sponsoring organization agrees to abide by all rules of Oregon Family Equestrian Activities.

## OFEA Show Approval Application 2008

**A liability disclaimer paragraph naming Oregon Family Equestrian Activities must be used on all show entry forms. Example:**

I hereby certify that every horse is eligible as entered. I make these entries at my own risk and understand that equine events are potentially dangerous. Show management, owners of the facility, and/or **Oregon Family Equestrian Activities** shall not be held responsible for any accident, injury, or loss that may occur to any exhibitor, their representatives, or to their horses, equipment, or vehicles. Presentation of this entry with my entry fee shall be deemed acceptance of the above. I understand and agree that this show shall be conducted under the rules of **Oregon Family Equestrian Activities** and that of the Show Management.

### **Amateur Classes**

Amateur classes do not count for OFEA year end awards. Effective January 1, 2008, OFEA will not approve open shows in which the only classes for adults 18 and over are Amateur classes.

### **Lead Line Exhibitors**

OFEA rules do not allow Lead Line exhibitors to cross-enter into ANY other riding classes in Open, Schooling and Gaming shows.

### **10 & Under Walk Trot Exhibitors**

OFEA rules do not allow members who compete in the 10 and Under Walk Trot Age Division to compete in ANY canter classes at Open, Schooling and Gaming shows.

### **Use of Approved Helmets**

OFEA rules require that approved helmets are mandatory for children and youth 17 and under in all Gaming and Hunter Hack classes.
