(*) Classes do not count for age division high points, but are counted for open division year end awards

(^) Class fees benefit charity. Can be used as schooling. NOT JUDGED!

•Show attire is required! Hat or helmet required in all classes.

•Leadline - Helmet required for equitation, may not cross enter to any other class

•10 & Under - may not enter canter classes or leadline - walk/trot classes only

•Age Division - may not cross enter into any other age division

•Junior Horse - 5 years old and younger

•Senior Horse - 6 years old and older

•MUST attend a minimum of two shows in the series to be eligible for the Series High Point Buckle with same horse/rider combo

•Overall Series Buckles for high points in each age division with same horse/rider combo

~Liability Release~ Read carefully, this impacts your rights - Participation Agreement, Notice Release, and Acknowledgement of Risk: I accept and clearly understand that riding a equine can be hazardous, especially in an equestrian event; that there are inherent and other risks involved in riding a equine; and that injuries are a common and ordinary occurrence. I freely accept and assume those risks. I therefore release Oregon Family Equestrian Association, Inc. (OFEA), its members and show grounds' owners and all their agents and employees, from any and all liability for damage and injury to myself, my equine, or to any person or property resulting from my riding a horse in this equestrian event, accepting myself the full responsibility for any and all such damage or injury of any kind which may result. I agree to fully indemnify, defend, and hold OFEA, show grounds' owners and all of their agents and employees, harmless from any and all claims, actions, liability, or costs including attorney fees and other costs of defense, arising out of or in any way related to my riding a equine in this equestrian event. The limitations on liability provided in ORS 30.691 shall apply to an adult participant in the circumstances listed in subsection (1)(b) of this section if the participant, prior to riding, training, driving, grooming or riding as a passenger upon an equine, knowingly executes a release stating that as a condition of participation, the participant waives the right to bring an action against the equine professional or equine activity sponsor for an injury or death arising out of riding, training, driving, grooming or riding as a passenger upon the equine. A release so executed shall be binding upon the adult participant. I hereby certify that every equine is eligible as entered. I make these entries at my own risk and understand that equine events are potentially dangerous. Show management, owners of the facility, and/or Oregon Family Equestrian Association shall not be held responsible for any accident, injury or loss that may occur to any exhibitor, their representatives, or to their equines, equipment, or vehicles. Presentation of this entry with my entry fee shall be deemed acceptance of the above. I understand and agree that this show shall be conducted under the rules of Oregon Family Equestrian Association and that of the Show Management.
